## ACT Test Day Safety Protocol

Our test center area will be cleaned and disinfected prior to testing in accordance with CDC guidelines.

We will have hand sanitizer and sanitizing wipes available on test day.

Testing staff members will wear masks and on test day.

Examinees will be screened with required health and wellness questions during check-in.

Examinees will be seated a minimum of six feet apart while testing.

### Guidelines for Examinees

The following Examinee Safety Guidelines will be provided to all test-takers.

- ACT recommends all examinees wear masks on test day.
- Examinees will be asked to remove masks for inspection and full facial confirmation at check-in.
- Examinees are expected to adhere to social distancing practices (remain six feet apart) throughout the test day.
- Examinees are instructed to understand the signs and symptoms of COVID-19 and to stay home if any of the following are true:

Do you have any of the following more **common symptoms**?

- fever greater or equal to 100.4 degrees Fahrenheit
- new onset and/or worsening cough
- difficulty breathing,
- new loss of taste or smell

Do you have any of the following **less common symptoms**?

- sore throat
- nausea, vomiting, diarrhea
- chills, muscle pain, excessive fatigue
- new onset of severe headache
- new onset of nasal congestion or runny nose

Have you come into close contact (15+ minutes) with someone who is being evaluated/tested for or has a laboratory confirmed COVID-19 diagnosis in the past 14 days?
